CEO Update

Welcome to our Fall Update Newsletter!

I hope you all had an enjoyable summer and found some time for rest and rejuvenation. As summer has turned to Fall, we can look forward to Thanksgiving Day and recall all of the many blessings we have received from our heavenly Father. The change of seasons and change in general can be disruptive and unsettling at times. We can be thankful to God that throughout the changes and challenges we face, our loving God is constant. As it says in Hebrews 13:8: Jesus Christ is the same yesterday, today and forever.

An exciting change happening at our Credit Union this Fall is that we will be opening our new Calgary branch. We are looking forward to having **Jade**, **Nonso** and **Leonard** working out of this location and providing our existing members, and hopefully new members, with more in-person advice and service. We plan to have a Grand Opening celebration sometime in the new year and we will provide details on this in our Winter Newsletter.

You can also see in this newsletter that we are updating our Youth Banking Program. For decades our Credit Union has been partnering with schools to both encourage our children to save and teach financial literacy. We are extremely grateful to the volunteers who make this program a reality in 12 different schools across Alberta. Since just 2017, our Credit Union has paid \$84,000 in bonuses to students who have achieved their savings goals and over \$74,000 in matching bonuses to participating schools. The reason for the difference in amounts is that students can participate in this program even if they are not a member of a participating school. If your child or your school is interested in being part of this program, please contact a member of our team.

We will be holding our annual All Staff Meeting on November 29 this year. This is an important time to review strategy and engage in team building. We ask for your understanding as our offices will be closed for either all or part of this day. There has been significant change in our leadership group. In September, our Chief Financial Officer, **Bryan Fiebich** left our Credit Union to take up a new challenge as VP Finance at Vision Credit Union. Bryan has contributed to the success of the Credit Union in many ways over the past 17 years and he will be missed. At the same time, this has created a new opportunity for **Neil Loogman** to be promoted to the role of Controller. Congratulations, Neil! We wish Bryan all the best and we are thankful that we will continue to work with him in the greater Credit Union system.

This newsletter also mentions a change to our hold policy that will be implemented in November. Fraud activity has increased and we are at a point where it is necessary to manage this risk by applying holds to most of our accounts. We have given lots of notice so that there is time to discuss with members how to adjust to this change. If the addition of holds is going to cause you either hardship or significant inconvenience, please reach out to a member of the team to discuss your concerns.

Throughout the changes that we experience in our lives, when we put our confidence in God we can find the strength we need in Him. As it says in Jeremiah 17:7-8:

But blessed is the one who trusts in the Lord, whose confidence is in him.



Compass Curriculum

We have partnered with Compass (compassfinancialministry.org) to offer curriculum specifically designed for home school, high school, and college courses. The Compass Curriculum will improve your finances (and life) by guiding you to apply God's principles to your specific financial circumstances. It's all about doing it God's way. We plan to pilot the curriculum with a few participating schools this year.



Savings Goals and Bonuses

We've made it easier for youth to meet their monthly savings goal and increased the monthly bonus youth qualify for. Youth also qualify for a bonus for 12 months of the year instead of 10 months of the school year. We've simplified the bonus structure and made it easier for youth and parents to understand.



Bible Bingo

Bible Bingo cards for youth in grades 1-3, 4-6, 7-9, or 10-12 are now available from a participating school or a Christian Credit Union branch. Each card includes 8 Bible verses. Your child's goal is to memorize each verse over the duration of the school year (September to May). When the card is completed, signed off by a parent or volunteer and returned to Christian Credit Union, your child will receive a special bonus! The participating school with the highest percentage of completed cards will also get a reward!



Grade 2 Field Trips

We are excited to offer field trips for Grade 2 students at participating schools. The field trip includes an introduction to Credit Unions, tour of the vault, role playing as a Christian Credit Union team member, and story time with a financial lesson. Each field trip participant will take home a Give, Save, Spend, barn.



Hold Policy

To prevent fraud, we will be applying a hold policy for all members effective November 5, 2024.

Here are some details on the policy:

When you make a deposit to your Personal, Business or Non-Profit account at Christian Credit Union, your account is instantly credited the amount of the cheque. You may not be able to access the full amount of the funds from that deposit immediately, as a hold may be placed on some or all your deposits.

The purpose for a hold to be placed on the deposit of a cheque is that a cheque is different from cash - it is a promise to pay from one party to another party. If the account the cheque is issued from does not have enough funds, or if the cheque is fraudulent, the cheque will be returned, and the member's account will be debited the amount of the deposit.

The length of the hold will be 5 calendar days for cheques.

- a) 5 calendar days for Remote Deposit
- b) 5 calendar days hold for all ATM deposits and in branch deposits.
- c) 10 calendar days for "out of province" cheques in branch
- d) 20 calendar days for US cheques in branch
- e) Federal Government of Canada cheques are not held in branch.

We are unable to view the individual item(s) deposited at an ATM, therefore the hold applies to all of the items deposited. When you deposit via Remote Capture, we can view the cheque the next business day and remove the hold (in part or all), at our discretion, once we have viewed the cheque.*

Please note: e-Transfers and automatic deposits will not be held.
